## HELPING YOU REDUCE YOUR WATER BILLS

What is sewage tax and who is exempt from paying it?

### WHAT IS SEWAGE TAX?

This is a tax that is included in water bills for the supply of the following services: special control and cleaning activity, operation, conservation and development of the municipal sewage network.



### WHAT DO I HAVE TO DO TO BE EXEMPT FROM IT?

- Once the relevant municipal services have issued reports confirming the person's or household's residential-exclusion or vulnerable situation, the information will be passed on to the service supplier so that it directly applies the exemption.
- This exemption will take effect from the date of the above-mentioned reports and continue up to the end of the confirmed situation.
- The procedure is free.

Barcelona City Council approved an amendment to Tax Byelaw number 3(5) on Sewage Taxes at its Full Municipal Council Meeting of 6 October 2017. This amendment establishes **tax exemption for people with a water-supply contract who are in a residentialexclusion situation.** The amendment came into force on its publication in the Official Barcelona Provincial Gazette of 19 October 2017 and is reinforced under Act 24/2015, for vulnerable situations notified by the municipal social services.

### WHO MAY BE EXEMPT FROM PAYING THE TAX?

 People who are in situations of residential exclusion or vulnerable situations recognised by the municipal social services and who have supply contracts with residential water networks.





## WHO IS AT RISK OF RESIDENTIAL EXCLUSION?

Income is one of the determining factors in a possible situation of a risk of residential exclusion. The reference is the Catalan Income Sufficiency Indicator (IRSC), currently set at 569.12 euros a month and 7,967.73 euros a year. The following collectives are at risk of residential exclusion:

PEOPLE WHO LIVE ALONE,

where their income is less than 2 times the IRSC.





#### HOUSEHOLDS

(homes with two or more people), where their income is less than 2.5 times the IRSC.

#### PEOPLE WITH DISABILITIES OR CONSIDERABLE DEPENDENCY,

where their income is less than 3 times the IRSC.

Where the income is more than 1.5 times the IRSC, a report will be required from the social services confirming the risk of residential exclusion.
